



Polypropylene Based Products 25-Year Limited Warranty

ClarkDietrich Building Systems (“ClarkDietrich”) warrants to you, the original owner of its polypropylene based product, that when installed in conjunction with the proper application and in accordance with ClarkDietrich’s published installation instructions, is free from manufacturing defects for twenty-five (25) years after the date of installation when the new application installed with said polypropylene-based product is warranted for twenty-five (25) years by the cladding manufacturer, or for such shorter period of time-based on the warranty period of the new application if less than twenty-five (25) years.

The warranty is valid only when the polypropylene-based product is installed, finished, and maintained according to ClarkDietrich’s written installation instructions. This warranty does not cover damage of any kind resulting from improper use, improper installation, fire, flood, earthquake, storm, tornado, or other acts of God, structural shrinkage, distortion of the sidewall or materials to which the polypropylene-based product is applied, deterioration of the cladding, or any other cause beyond the control of ClarkDietrich.

ClarkDietrich’s warranty is expressly limited to the building owner at the time of initial installation. Other applications may be covered with written approval provided by ClarkDietrich. The warranty is nontransferable.

Claims under this warranty must be made in writing to ClarkDietrich within the applicable warranty period and within thirty (30) days after the discovery of the defect. Such claims must refer to the date of purchase and the installer’s name and address. Claims should be addressed to: ClarkDietrich Building Systems Attention: Warranty Claims 9050 Centre Pointe Dr. Suite 400 West Chester, OH 45069. ClarkDietrich shall have a reasonable opportunity to inspect the polypropylene-based product involved for defects before repairs are begun. If the polypropylene-based product contains a defect covered by this warranty, ClarkDietrich, at its sole discretion, will either (a) pay for the cost of our materials or replace the polypropylene-based product, (b) provide a replacement polypropylene-based product of equal quality or value as a substitute, or (c) refund the original purchase price of the polypropylene-based product. In no event shall ClarkDietrich be obligated to pay for the cost of labor for such repair or maintenance.

ClarkDietrich makes no express warranties except such as set forth herein. The remedies provided in the above express limited warranty are the sole and exclusive remedies available to you. No other express warranties are made. ClarkDietrich’s complete liability and the owner’s exclusive remedy are limited to repair, replacement or refund on the basis stated herein. All implied warranties, including but not limited to any implied warranty of merchantability or fitness for a particular purpose or use, are limited in duration as set forth above. In no event shall ClarkDietrich be liable for any incidental, special, or consequential damages.

This warranty shall not apply to polypropylene-based products sold outside of the United States or Canada. This warranty gives you specific legal rights, and you may have other rights that vary from state to state or provinces within Canada.
